Community Shred, Hazardous Waste Collection Planned

Two local events this fall will help residents who are decluttering their homes and garages at the beginning of the school year.

On Saturday, Sept. 24, Loudoun County will host a household hazardous waste collection event at the Harmony Park and Ride on East Colonial Highway in Hamilton. The event runs from 8:30 a.m. until 2:30 p.m. and is free to Loudoun County residents.

The event will be the last to occur in the western region of the county during 2016 and will be a convenient opportunity for residents to dispose of their unused summertime chemicals like pesticides and lawn mower gas. The purpose of this program is to provide a safe, no-cost method for residents to dispose of unused, old or unwanted hazardous materials stored in their homes.

Household hazardous waste is any waste produced in the home that is dangerous or potentially harmful to health or the environment.

Please note certain items will not be accepted such as motor oil, antifreeze, lead acid batteries, propane tanks, fireworks and ammunition, medical waste and prescription medications, and electronics. Alternative disposal methods are listed on the website.

These events will not be able to accept waste from businesses or local government agencies; however, a separate commercial waste event will be offered this fall at the County landfill.

On Saturday, Oct. 22, the Town of Round Hill is sponsoring a Community Shred Event from 10 am to noon at Round Hill Elementary School.

Residents will need to be in line no later than 11:30 a.m. to participate in the shred event. Shredding will end promptly at 12:00 noon.

There will be town staff and signs to direct residents during the event.

Guidelines for the event:

1. Two boxes or trash bags per vehicle (Xerox box size)

2. Residents will form a single line in parking lot.

3. PROSHRED employees will bring bins to each vehicle in line to retrieve material to be shredded.

4. For safety reasons residents must remain in their vehicles. PROSHRED employees will return boxes/bags upon request.

5. Residents who want to watch their papers being shredded must remove their vehicles from the line and park away from the truck and then walk to the back of the truck to watch the shredding.

Accepted materials: office paper, checks, envelopes, and small fasteners such as staples, paper clips and binder clips.

Items not accepted: newspapers, magazines, 3-ring binders, cardboard, plastic and electric media
