# Round Hill Earns a 2020 Tree City USA Designation

The Town of Round Hill was named a 2020 Tree City USA by the Arbor Day Foundation in honor of its commitment to effective urban forest management. The mayor officially announced the designation at the Town's Arbor Day celebration on Friday, April 30.

Cub Scout Troop #961, members of the Round Hill Tree Board, and the 2021 Arbor Day Poster Contest Winner, Charlie Pouy, and his family also attended.

The Tree City USA program is sponsored by the Arbor Day Foundation in partnership with the U.S. Forest Service and the National Association of State Foresters.

Round Hill achieved Tree City USA recognition by meeting the program's four requirements: a tree board or department, a tree-care ordinance, an annual community forestry budget of at least \$2 per capita, and an Arbor Day observance and proclamation.

"Everyone benefits when elected officials, volunteers and committed citizens in communities like Round Hill make smart investments in urban forests," said Matt Harris, chief executive of the Arbor Day Foundation.

"Trees bring shade to our homes and beauty to our neighborhoods, along with numerous economic, social and environmental benefits," he added.

# Filter Failure at Water Treatment Plant Leads to Usage Restrictions

All customers of the Round Hill utility system remain in mandatory water restrictions until further notice. The Town Council voted to implement phase 1 restrictions on April 14 after being briefed on operational pressure problems at the Goose Creek Water Treatment Plant that has resulted in several line failures within the plant.

The Council will be updated on the repair progress at its next meeting on May 19 and will decide at that time whether to lift restrictions, go to voluntary conservation or keep mandatory restrictions in place.

Under Mandatory Water Conservation Status, Phase 1, all customers of the Town's water system are requested to conserve wherever and whenever possible in their normal consumption of water.

Furthermore, using water from the Town's system to water lawns, wash cars, fill swimming pools, and like activities is prohibited. Residents may not use sprinklers or irrigation systems for gardens.

Any person or customer found conducting any of these prohibited uses shall be subject to a fine not to exceed \$500 dollars for each violation.

The problem was caused when a massive filter system used in the water treatment plant failed, which required the plant and two wells to be taken offline while emergency filter media replacement and valve repairs are completed.

These filter media products are not "off the shelf" and are typically made on-demand for each individual complex filter system. This will add to the time required to complete the intense repair and rehab process.

The 11 wells in the Round Hill water system typically run 10 hours a day when all wells are fully operational. With the Goose Creek water treatment plant and its wells offline, the remaining wells are running upward of 20 to 24 hours a day to meet current customer demand. Pushing these wells beyond their normal run times leaves the system vulnerable to additional system failures.

The water remains safe and clean to drink. However, the Town is concerned about additional wells failing to produce water to keep up with demand.

Round Hill needs the community to conserve water in order to keep the water system running until all emergency repairs are complete.



### RH Appalachian Trail Festival Returns to B Chord Brewing

Though the pandemic scrapped plans for a festival last year, the Round Hill Appalachian Trail Festival will return to B Chord Brewing this September.

This year the festival expands to two days, Saturday, Sept. 11, and Sunday, Sept. 12.

The free family-friendly event celebrates the A.T. and other outdoor opportunities in the area by toasting the beauty of the trail with brews and bites, tunes and talks.

On Saturday, expect a day of live music, trail talks, kids' activities, food trucks, and vendors.

Talk with representatives from 10 environmental/hiking groups. Bid on hiking poles or restaurant gift cards in the silent auction.

Saturday bands include Justin Trawick and the Common Good, and speakers include author/hiker/photographer Cindy Ross.

On Sunday, the festival focuses on hands-on (and feet-on) activities and workshops. Join an edibles hike, practice yoga for hikers, cook over the campfire, sketch from nature, pick up first aid and photography tips.

#### ASSISTANCE FOR ROUND HILL UTILITY CUSTOMERS

# NEXT TOWN ELECTIONS TO BE HELD IN NOVEMBER 2021

Elections for Round Hill mayor and Town Council have traditionally occurred in May of even-numbered years. However, in February, the Virginia General Assembly passed a bill requiring all municipal elections scheduled after Jan. 1, 2022, to be held in November.

Following a public hearing on April 7, the Round Hill Town Council adopted an amendment to the Town Code that changes the mayor and council elections from May in evennumbered years to the November general election in odd-numbered years.

As a result of this change, the next Town elections will be held on Tuesday, Nov. 2, 2021. The offices of mayor and three council members will be on this ballot.

Candidates for office must be registered voters who have lived in Virginia for at least one year and within the corporate limits for the Town of Round Hill for at least six months. The filing deadline is Tuesday, June 8, at 7 p.m.
