With the expiration of the Governor's executive orders regarding the COVID-19 Pandemic on June 30, 2021 and the Town Council's action on June 16, 2021 to end the Local State of Emergency to coincide with the end of the Governor's State of Emergency, the Round Hill Mayor and Town Council will resume meeting in person at the Town Office, 23 Main Street, Round Hill.

Effective Monday, August 9, 2021, Loudoun County Government will require all employees and visitors to county facilities — regardless of vaccination status—to wear face masks while inside all county facilities in a renewed effort to reduce levels of community transmission of COVID-19. This reinstating of the mask requirement follows the recommendations of the Centers for Disease Control and Prevention (CDC), Virginia's Governor and the Loudoun County Health Department. Loudoun County Public Schools also has its own mask requirements.

In response to the Loudoun County Government mask mandate, the Town of Round Hill has reinstated its own mask policy starting August 19, 2021.
