IN RE: CALL TO ORDER

Mayor Ramsey called the meeting to order at 7:10 p.m.; a quorum was present.

IN RE: PUBLIC COMMENT

There was no public comments

IN RE: ACTION ITEMS

FY2016 Budget Line Adjustment - Well Exploration

Town Administrator Nicholson went over the packet information provided to the Council. The first item was a memorandum in regards to the Budget Adjustment for the Well Exploration. Prior to June 30, 2016, Emery & Garrett will need to purse exploratory test drilling and subsequent preliminary testing of yield and quality on 5 properties. Total costs for the exploration is \$174,250. Additional fees will include well permits (approximately \$600 per well) from Loudoun County and providing of drill rig access to selected well sites (costs to be determined). In order to work within the present budget and allow for exploration of various well sites that could be incorporated into the town's water system, a revision of the budget will need to be done. A public hearing will not be required nor will a motion by the council be needed. In order to provide the adjustment money from the Utility CIP Fund in the amount of \$189,600 will be moved from Raw Water Line – Greenway Drive/719 and moved to Well Exploration. Right now in well exploration there is \$58,400 budgeted for FY 16. There would be no changes to the Utility CIP Budget totals; totals would remain \$870,652. Town Administrator Nicholson advised the Council that if the adjustment is not approved that money is not in the FY17 budget to do the well exploration.

Town Administrator Nicholson then went over the Service Contract from Emery & Garrett for the request of \$174,425. Councilperson Lyne was concerned about the short notice given to the council for the budget adjustment and does not feel comfortable approving such a large adjustment on short notice. Councilperson Lynn stated maybe the town should go out for another bid. Mayor Ramsey explained that the town is now in Phase III and would not be a good time to go out for bid. Mayor Ramsey said that a Resolution could be done to adjust FY17 Budget to allow adjustment.

Following this discussion, a vote was held to approve the contract for Emory & Garrett; the motion was approved 4-1. The vote is recorded as follows:
